Programme of your Institution under The West Bengal University of Teachers' Training, Education Planning and Administration for the academic year 2018-2019 subject to the fulfillment of the following terms and conditions:

1. The college shall be guided by the NCTE Regulations 2014 in respect of appointment of teaching and non-teaching staff, purchase of books, audio-visual material and automation of the library.
2. The college will continue to organize and equip the laboratories as per stipulation of NCTE. Other infrastructure are to be maintained as per NCTE norms.

It is advised to make payment to the staff of the college through A/C payee cheque drawn on a (preferably) Nationalized Bank. Stern action shall be taken if any irregularities are found in this regard.

9. Admission of students will be as per norms stipulated by the University.
10. Staying in the college hostel, if any, is not mandatory for the students.
11. The Governing Body of the College is to be constituted as per provisions of the State Govt. / Affiliating University.
12. The following school subjects are approved as Pedagogy subjects for curriculum transaction at your college along with other foundation courses and optional courses, if any :
Bengali, English, Mathematics, Geography, History, Life Science, Physical Science, Education, Sanskrit.
